The November meeting of the New York Division, Electric Railroaders' Association will be held on Friday, November 20, 2009 at the St. John's University Manhattan Campus (formerly the College of Insurance) building, at 101 Murray Street, between Greenwich and West Streets, in downtown Manhattan. The University is a three block walk [1-1/2 blocks south and 1-1/2 blocks west] from the Chambers Street station of the West Side IRT Subway. The doors open at 6:15 PM, and the meeting commences at 7:15 PM. Bring your 2009 membership card with you for admission. THE DOOR FEE FOR NON-MEMBERS IS \$10.00. ## TRIP PLANS FOR 2009 AND 2010

Saturday, November 7 – a trip involving Hudson-Bergen Light Rail. As the flyer that went out with the October mailing indicates, we will start with a ferry ride from W. 39<sup>th</sup> Street to Port Imperial and then plan to ride HBLR in its entirety, including a lunch break at the Newport Mall. We will view the construction progress from 22<sup>nd</sup> to 8<sup>th</sup> Streets in Bayonne from a charter bus. **There will be a special optional trip after our charter bus drops us off at Journal Square.** Those interested can, at their own expense, ride with us on PATH to Harrison, where PATH will permit us to spend about 15-30 minutes on the Newark-bound platform to take photos of passing PATH, NJ Transit and Amtrak trains. As you know, PATH has a strong policy against taking photos on its property, so getting its OK to do it this once will be a rare treat for the train photographers amongst us. Here are some very tentative dates, for the most part, for possible trips in 2010: (1) Saturday, February 20 – definite date for our annual Grand Central Terminal tour; (2) Saturday, March 20 – possible date for a return visit to the 207<sup>th</sup> Street Subway Shops (we figure some of the last R-32s may be there at that time, preparing for reefing); (3) Saturday, April 17 – possible date for the twice-postponed Staten Island Railway charter on the new BL20G replacement diesels for the Alco S-1s; (4) Other possible 2010 trips – return to the PATH Harrison shop; a weekend overnight trip to the Lancaster, PA, area; and a joint-trip with the NY Rail Road Enthusiasts.
