

#### **DEPARTURE TIMES**

Each attendee is responsible for being at the departure point(s) several minutes prior to the scheduled departure time. It is your responsibility to check for g.o.'s and other service notices that may affect your trip beforehand, so that you can plan your arrival time with plenty of cushion to spare. There will be no ticket refunds for failure to show up on time. It is important that you adhere to announced return departure times.
